# ARTICLES OF INCORPORATION OF CHADMAR, INC.

### ARTICLE I CORPORATE NAME

28 H. T. T.

The name of the corporation is CHADMAR, INC.

# ARTICLE II DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

# ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV CAPITAL STOCK
