ARTICLE I. - NAME

The name of this corporation is **ASSOCIATION OF KANNADA KOOTAS OF AMERICA, INC.**



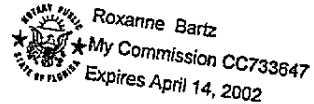
