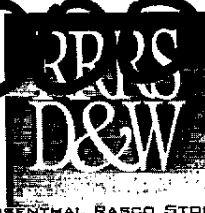

**ARTICLE ONE:**

The name of this corporation is: PHYSICIAN CREDENTIALING, INC.


