ARTICLES 1: NAME

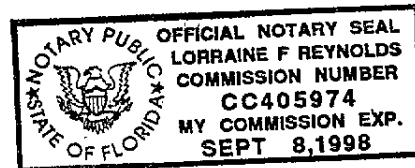
