Articles of Incorporation for JAMMIN BEANS PRODUCTIONS, Inc.

ARTICLE I. CORPORATE NAME

The name of this corporation is: JAMMIN BEANS PRODUCTIONS, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of developing and engaging within the areas of entertainment and accessory related services and products thereto, and other contractual related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.

ARTICLE III. CAPITAL STOCK
