

**ARTICLE I - CORPORATE NAME**

The name of this corporation is AGRI COMMUNICATIONS, INC.

manifesting their intention that a certain amendment of these Articles of Incorporation be made.



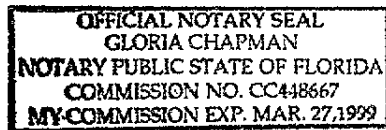


