ARTICLES OF INCORPORATION OF ANCHOR VAN LINES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the House DA Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME
