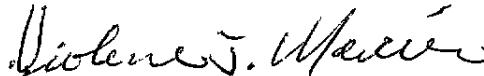
Article VII – Consent in writing in lieu of meeting

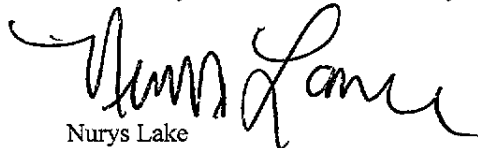

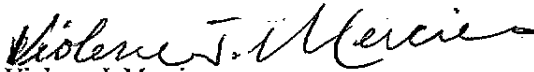
