ARTICLE I-NAME

The name of this corporation is M. SILVERS. INC.

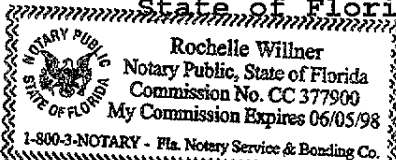
