ARTICLES OF INCORPORATION FOR A F GARDENS TRUCKING, INC.



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is A F GARDENS TRUCKING, INC.

ARTICLE II: DURATION:
