The undersigned incorporator, for the purpose of forming a business corporation under the Florida Business Corporation Act, hereby adopts and files the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be Soundset USA, Inc.

The corporation shall have the power to engage in any lawful activity for which corporations may by organized under the Florida Business Corporation Act.
