The power to adopt, alter, amend or repeal by – laws of this Corporation shall be vested in the Board of Directors of the Corporation.


ARTICLE IX – DIRECTORS COMPENSATION



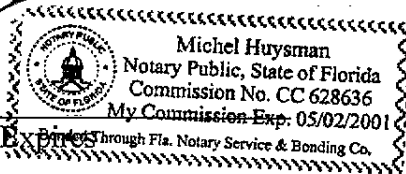


