This letter is in response to the correspondence noted above. Copies of both letters, plus my correspondence to you, dated May 2 are attached.

Your letter of May 20 was in response to my letter of May 2, in which I explained our problems during Hurricane Charlie. As you will note, your letter of May 20 instructed us to return a corrected Annual Report and the \$150.00 within 30 days of the date of your letter to avoid the later filing fee. We had a corrected Annual Report and our check submitted to the Division of Corporations within that period of time and concluded that the matter was resolved.

However, subsequently we received a letter from the Annual Reports Section stating that we owed a late fee, in direct contradiction to what your letter instructed. We have tried to call for an explanation and have not been able to get through to anyone.
