Dear Sir or Madam:

We received your letter of September 1, copy attached. Attached is a copy of our Annual Report with our registered agent's approval signature.

In addition, however, the situation has become somewhat confused. In June we received a letter from Ms. Sutphin's of your office(referenced above). At that time she indicated that you needed the registered agent's signature, that she was holding our initial \$150.00, and that if we complied with her request to send another Annual Report with the agent's signature within 30 days of the date of her letter (her letter was dated May 20), we could avoid the penalty. We immediately obtained the signature and resubmitted the report in June and thought that the matter was resolved. It is not clear what happened to that copy of the Annual Report.

Later we received a form letter saying that if we did not pay the \$400.00, we would lose our status. Since that correspondence contradicted what Ms. Sutphin had instructed us to do, we were extremely concerned and wrote the Division of Corporations again on July, providing the details of all that had transpired and asked that your office review the matter and call us. We waited quite some time and received no response. Therefore, as we neared the due date to paying the penalty, although we did not think based on Ms. Sutphin's letter that we owed it, we paid it anyway.

As we asked in our July 5 letter, we would appreciate an Annaul Reports Section supervisor reviewing the matter with the hope that we will get the \$400.00 back. In any event, the attached copy of our Annual Report should at least respond to your most recent letter and put us in good standing.

In closing, let me add that both officers of our corporation are in their 70's. We were victims of Hurricane Charlie and ultimately left Florida. We are trying to get our life back in order and want to ensure that we have complied with all your requirements. However, we also want to ensure that we have not overpaid.
