The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. NAME

The name of this corporation shall be J.C. DOMINIQUE, INC.

Article II. PLACE OF BUSINESS

The principal place of business of this corporation shall be ⁸⁶³¹3681 Burning Tree Circle, Largo, Florida 33777.

Article II. NATURE OF BUSINESS
