

ARTICLE ONE

The name of the corporation is **INTERNATIONAL MULTI-LISTING SERVICES, INC.** The principal address of the corporation is: **6933 S.W. 16th Court, Pompano Beach, Florida 33068.**

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.


