ARTICLES OF AMENDMENT

TO THE ARTICLES OF INCORPORATION OF

SPACE COAST ANESTHESIA, INC.

SPACE COAST ANESTHESIA, INC., a Florida corporation, hereby adopts Article Amendment to its Articles of Incorporation as follows:

- I. The name of this corporation is SPACE COAST ANESTHESIA, INC.
- II. The Articles of Incorporation of the corporation are hereby amended as follows:
 - A. Article I is hereby deleted in its entirety and replaced with the following:

"ARTICLE I - NAME AND ADDRESS

The name of this corporation is SPACE COAST ANESTHESIA, P.A., located at 1340 Medical Park Drive, Suite 202, Melbourne, Florida 32901"

B. Article III is hereby deleted in its entirety and replaced with the following:

"ARTICLE III - PURPOSE

The purpose of the corporation is to engage in every phase and aspect of the business of rendering professional services to the public that any doctor of medicine duly licensed under the laws of State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice medicine. At its option, the corporation may enter into partnership with qualified professional service corporations incorporated under Chapter 621 of the *Florida Statutes* and/or individuals duly qualified to practice medicine in the State of Florida. This Article III shall be construed as enumerating both powers and purposes of the corporation; it is expressly provided hereby that the foregoing enumeration of the specific powers and purposes shall not be held to limit

or restrict in any manner the purposes or powers of the corporation otherwise permitted by law and includes the powers and purposes to manufacture, design, construct, own, use, buy, sell, lease, hire and deal in and with articles and property of all kinds and render services of all kinds, and to engage in any legal and lawful act or activity for which professional service corporations may be organized under the State of Florida."

III. Each amendment contained in these Articles of Amendment was adopted on the 23 day of March, 2000.

IV. Amendments contained in these Articles of Amendment were approved by the shareholders and the number of votes cast for the amendment by the shareholders was sufficient for approval. The corporation has a single class of stock.
