OF

ARTICLE I - SWEET HOME MORTGAGE CORPORATION

The name of this corporation is SWEET HOME MORTGAGE CORPORATION.



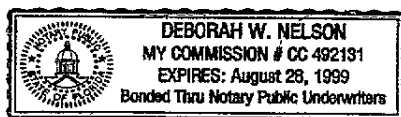


