



## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF G. LEX STEVENS, M D. P.A.

These Articles of Amendment amend the Articles of Incorporation of G. Lex Stevens, M.D. P.A. filed with the Secretary for the State of Florida on June 3, 1998, as Document Number P98000049477.

1 Amendment - Change of Corporate Name.
