CERTIFICATE OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions;

**ARTICLE ONE**

The name of the corporation shall be:

*CREATIVE VISIONS GROUP, INC.*

**ARTICLE TWO**

The corporation may engage in any activity of business permitted under the laws of the United States of America and of the State of Florida.

**ARTICLE THREE**

The maximum numbers of shares of stock, which the corporation shall have outstanding at any time, shall be 10,000 Shares of stock, which shall be common stock of a par value of 1.00 Dollar per share. All of any part of the capital stock may be paid for either in lawful moneys of the United States of America, or in services, at a true valuation thereof.

**ARTICLE FOUR**

This corporation shall begin business with a minimum capital of the amount of 1,000.00 Dollars.

This corporation shall have perpetual existence.
