### ARTICLES OF INCORPORATION

FEDERAL SERVICE SECURITY.

Selly To The undersigned subscribers to these Articles of Incorpora natural persons competent to contract, hereby form a corpora under the laws of the State of Florida.

#### ARTICLE I

#### NAME

The name of the corporation is FEDERAL SERVICE SECURITY, INC.

#### ARTICLE II

#### DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

#### ARTICLE III

#### PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV

#### CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock designated as common stock. The maximum number of shares of common stock which the corporation is authorized to have outstanding is 100 shares of common stock of a per value of \$1.00 per share. 
