ARTICLES OF INCORPORATION 98 JUN -3 PM 2:01

The undersigned, acting as incorporator of an Association under Chapter 621 of the Florida Statutes, adopts the following Articles of Incorporation:

First: The name of the Association is:

Second: The principal office of the Association is:

Third: The period of its duration is perpetual unless sooner dissolved.

Fourth: The specific purpose for which the Association is organized is to provide personal services to the public which require, as a condition precedent to the rendering of such services, the obtaining of a license or legal authorization, pursuant to Section 621.03, Florida Statutes, including, without limitation, the personal services rendered by certified public accountants and public accountants.

Fifth: The Board of Directors of the Association shall consist of such number as the shareholders may select at each annual meeting of shareholders.




