ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ACTION DAY LABOR, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is ACTION DAY LABOR, INC.
- 2. The following amendments of the articles of incorporation were adopted by the shareholders of the corporation on November 3, 1998, in the manner prescribed by the Florida Business Corporation Act:
