

I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of the corporation is M&S Automotive Group, Inc.

ARTICLE II Principal Office and Mailing Address

The address of the principal office of the corporation is 1701 East Sunrise Boulevard, Fort Lauderdale, Florida 33304.

ARTICLE III Purposes
