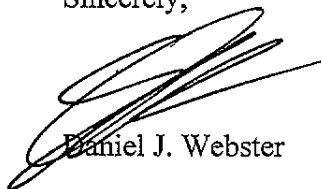

ARTICLES OF INCORPORATION

OF

AGAPE BUSINESS CONSULTANTS, INC.

6/1/98

The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes (1997).

ARTICLE I

(Name of the Corporation)

The name of the corporation is Agape Business Consultants, Inc. (hereinafter the "Corporation").

ARTICLE II

(Corporate Existence)

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on June 1, 1998, and this Corporation shall have continuous and perpetual existence thereafter.

ARTICLE III

(General Purpose of Corporation)

The general purposes for which the Corporation is initially organized are as follows:

- (a) To transact business as a consulting and management firm; and
- (b) To transact any other lawful business for which Corporations may be incorporated under Chapter 607, Florida Statutes.

#### **ARTICLE IV**

##### **(Authorized Shares, Par Value)**

The aggregate number of shares which the Corporation shall have authority to issue is Ninety-Nine (99) shares. These shares shall consist of only one class, and that class shall be known as "common shares" of the Corporation. Each share shall have a par value of One dollar (\$1.00) per share.

#### **ARTICLE V**

##### **(Shareholders' Preemptive Rights)**

When a new issue of shares of the Corporation is offered by it for sale and the consideration to be paid for such issue is to be paid in cash, each existing shareholder shall have the preemptive right to purchase his pro rata number of shares, or fraction thereof, at the price at which the newly issued shares are to be offered for sale to other persons.

#### **ARTICLE VI**

##### **(Registered Agent and Address of Corporation)**

The name of the initial registered agent of the Corporation shall be Daniel J. Webster (hereinafter the "Registered Agent") and the street address of the initial registered office of the Corporation shall be 1020 West International Speedway Boulevard, Daytona Beach, Florida 32114. To signify acceptance of appointment as registered agent, the Registered Agent has signed these Articles pursuant to Section 607.034, Florida Statutes.

#### **ARTICLE VII**

##### **(Initial Place of Business)**

The street address of the initial principal place of business shall be 101 E. Union Street, Jacksonville, FL 32201.

## ARTICLE VIII

### (Board of Directors of Corporation)

The number of directors who shall constitute the initial board of directors of the Corporation shall be Three (3). The name and street address of each person who is to serve as a member of the initial board of directors of the Corporation is:

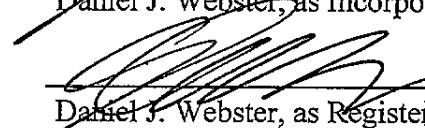

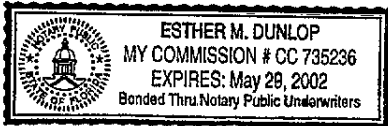
