ARTICLE I

CORPORATION NAME

The name of this corporation is The Network Institute, Inc.

ARTICLE II
PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock.
