**ARTICLES OF AMENDMENT TO ARTICLES
OF INCORPORATION OF**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (1993), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is South Miami Medical Chiropractic Center, Inc., (the "Corporation"), Charter No.: F98000010429, filed on the Fourth day of June 1999.
2. The following amendments of the Articles of Incorporation were adopted by a majority of the Shareholders, (the number of votes being sufficient for approval), and all of the Directors of the Corporation as of the First day of September, 1999, in the manner prescribed by Section 607.1003 of the Florida Business Corporation Act:

RESOLVED: That Article I of the Articles of Incorporation of South Miami Medical Chiropractic Center, Inc shall be amended to read as follows:

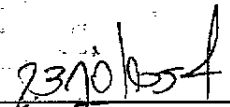
ARTICLE I
