## ARTICLES OF INCORPORATION

98 JUN 3 PM R. 20 The undersigned acting as subscriber (s) of a corporation under the Corporation Law, adopt the following Articles of Incorporation for suc Corporation.

# Article I

The name of the Corporation is ZAPATA-GONZALEZ CONSULTANTS, Inc.

### Article I

The purpose for which the corporation is organized is to engage in any activity or business permitted under the Law of the United State and the State of Florida, including but not limited to counseling individuals and organization on matters related to the profitable operation of their business.
