Dear Shawn,

Pursuant to your conversation concerning this corporation and the "penalties" I am requesting the "penalties" be removed. I make this request due to the following facts:

1. Error in "Principal Place of Business" & "Mailing Address" box. Note they are not the same and apparently our attorney of registry who is at the N. Miami address never received the first notice. The Ft. Lauderdale address is unknown and should never have been noted.
2. It appears that the Post Office changed the P.O. box to the old law firm address.
3. The address is "5"06, not "8"06 as I pointed out in our conversation.

As you can see by the copies of the attorney of record letters, we are just now getting this "second" notice from him in August.

I would appreciate you "adjusting" this matter for us and recording the proper address for future notices. It is my understanding that if the "penalties" are adjusted, the actual annual fee should only be \$150.

Our "principal place of business" address should be Marvin Moss, registered agent. We actually don't do any physical business in your State, so our "office" is his.
