We, the undersigned incorporator(s), hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of an incorporation for profit.

**ARTICLE I**

The name of the corporation shall be:

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the State of Florida and of The United States of America. The specific nature of business is: ATTORNEY AT LAW.

**ARTICLE III**

The maximum shares which the Corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock, which shares shall be no par value.

All stock is to be issued as fully paid and exempt from assessment.

**ARTICLE IV**

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the by-laws or written agreement among the stockholders which shall be on file in the office of the corporation.

## ARTICLE IX


