Name of Corporation



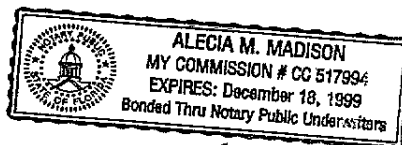
