The undersigned natural person of the age of eighteen (18) years or more, acting as an incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation is:  
SANFORD AERO CORPORATION

ARTICLE TWO

DURATION

The period of its duration is perpetual.

ARTICLE THREE

PURPOSE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which the corporation may be incorporated under the Florida Business Corporations Act.

ARTICLE FOUR

SHARES

The aggregate number of shares which the corporation shall have authority to issue is three-million (3,000,000) shares of common stock of no par value and one-million (1,000,000) shares of preferred stock of no par value.

ARTICLE FIVE  
COMMENCEMENT OF BUSINESS

The corporation will not commence business until it has received for the issuance of shares consideration of the value of One Thousand Dollars (\$1,000.00) consisting of money, labor done, or property actually received.

ARTICLE SIX  
REGISTERED OFFICE AND AGENT

The street address of its principal office and initial registered office is 1725 Hangar Road, Sanford, Florida, 32773, and the name of its initial registered agent at such address is J.A. Livanec.
