ARTICLES OF INCORPORATION

of

RSS LABORATORIES, INC.

ARTICLE I

CORPORATION NAME

The name of this Corporation is RSS LABORATORIES, INC.

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (1) Par value shall be \$1.00 per share.
- (2) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.
- (3) Except as otherwise provided by law, the entire voting power for the election of directors and all other

purposes shall be vested exclusively in the holders of the outstanding stock.

ARTICLE IV

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial office of this corporation is 1040 S. Federal Highway, Suite 100, Delray Beach, FL. 33483, and the name of the initial registered agent of this corporation at that address is KENT McNEAL. The Board of Directors may, from time to time, change the street and post office address of the corporation as well as the location of its principal office. The corporation shall have one (1) Director, initially. The number of Directors may be increased from time to time by the by-laws, but shall never be less than one (1). PRE EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which


