Enclosed please find the 2002 Uniform Business Reports (UBR) for W. M. Rollins, Inc. (Doc. #F95000005105) and W.M.R. Investment, Inc. (Doc. #(98000050525). Also enclosed are checks #100 and #509 in the amount of \$150 each, in payment of the Corporate annual fee.

We respectfully request abatement of the late payment penalty of \$400 on each Company based on the following reasonable cause. My client relied on me as his CPA to provide him instructions on the filing of these forms. Because he was out of town and I was not expecting these forms to be forwarded to me, I failed to provide him with the needed instructions.


