ARTICLES OF INCORPORATION

OF

RA/JAMM, INC.

A Florida Corporation

TALLAHAM PROSESSES The undersigned incorporator, for the purpose of forming a corporation under th Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be:
