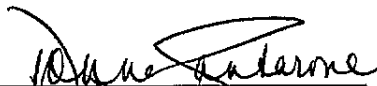
Article 1. be and it is hereby amended to change the name of the corporation to **DUFFY'S GOLF CENTER, INC.**

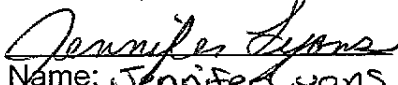
2. The foregoing amendment was unanimously adopted by the stockholders and directors of the corporation on June 27, 2000.
