ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is Osorio Furniture, Corp.

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

**ARTICLE XIII - CAPITAL AMOUNT**


The amount of capital with which this corporation shall commence business shall not be less than Five Hundred Dollars . . .00/100 - - (\$ 500.00).

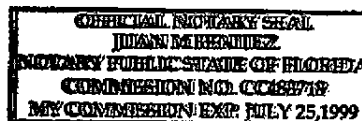
