**CERTIFICATE OF INCORPORATION
OF
HOPE IS UNLIMITED, INC.
A CLOSE CORPORATION**

FIRST: The name of this corporation is HOPE IS UNLIMITED, INC.

SECOND: Its registered office in the State of Florida at 1901 Helms Avenue Leesburg, Fl. 34748 County of Lake. The registered agent in charge thereof is HORIZON'S ARE UNLIMITED, INC. address "same as above".

THIRD: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.

FOURTH: The amount of total authorized capital stock of the corporation is divided into: 1000 shares of no par value.

FIFTH: The name and mailing address of the incorporator is: Loretta Dorsey Jacobs, 2532 Westchester Drive, West Palm Beach, Florida 33407

SIXTH: The powers of the incorporator are to terminate upon filing of the Certificate of Incorporation, and the name(s) and mailing address(es) of the persons who are to serve as director(s) until the first annual meeting of stockholders or until their successors are elected are as follows:

SEVENTH: All of the corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than thirty (30) persons.

EIGHTH: All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Section 202 of the General Corporation Law.

Each stockholder shall offer to the Corporation or to the other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he be elect to sell his stock.

NINTH: The corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.


TENTH: Directors of the Corporation shall not be liable to either the corporation or its stockholders for monetary damages for a breach of fiduciary duties unless the breach


