

# **Articles of Incorporation of Trust Project Management, Inc.**

The undersigned, for the purpose of forming a corporation pursuant to Chapter 621, Florida Statutes, hereby adopts the following articles of incorporation:

## **ARTICLE I - NAME**

The name of the corporation is Trust Project Management, Inc.

## **ARTICLE II - DURATION**
