Name and Address

At each election for directors, every shareholder entitled to vote at such elections shall have the right to cumulate his votes

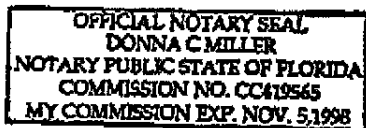
