

ARTICLES OF INCORPORATION

OF

PETER A. GERLICH, PA

ARTICLE 1: NAME AND ADDRESS

The name of this Corporation is : PETER A. GERLICH, PA and the address is: 11634 Ibis Lane, Port Richey, FL 34668.

ARTICLE 2: DURATION

This Corporation shall exist perpetually commencing on the date of this filing of these Articles with the Department of State.

ARTICLE 3: PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business in real estate sales and management.

ARTICLE 4: CAPITAL STOCK

ARTICLE 11: POWERS OF INCORPORATORS


The powers of the incorporators cease upon filing of the Articles of Incorporation.
