THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following Article of Incorporation.

**ARTICLE I  
Name**

The name of the corporation is **R&D EXPRESS TRUCKING, INC.**, and their principal place of business is **7664 Telford Court, Orlando, Florida 32818.**

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**

The general purpose for which the corporation is organized are:

1. To carry freight for hire, and load all varieties of commercial freight on board highway motor vehicles,, to transport such freight to various destinations in the State of Florida or throughout the United States and to buy, sell, and otherwise deal in and with tractors and trailer suitable for commercial trucking, and to maintain and repair the same.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, at the option of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares, Class A. Stock. The par value is \$1.00 share.

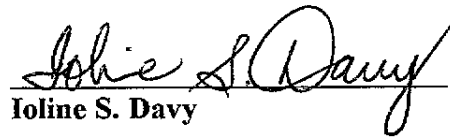

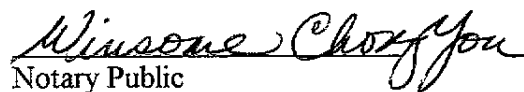
