## LITTLE CRUISERS CHILD DEVELOPMENT CENTER, INC.

#### **ARTICLE I - NAME**

The name of the corporation is Little Cruisers Child Development Center, Inc. (hereinafter called the "Corporation").

#### **ARTICLE II - PURPOSE**
