Dear Division of Corporations,

Please accept this letter on our behalf as an explanation for our late filing of our Corporation Annual Report.

We are submitting \$150 in lieu of the fact that we had never received any documentation stating that we needed to file. We did not receive the necessary papers to file our year end report and the fee through the mail. The following explanation provides an account as to why we feel we should not be penalized.
