ARTICLES OF INCORPORATION

OF

SOLALIGHT, INC.

EFFECTIVE DATE

ARTICLE I - Name and Address

The name of this Corporation is SOLALIGHT, INC. The Corporation's principal address is 941 S.W. 8 Street, Pompano Beach, FL 33069.

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on June 3, 1998, the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE III - Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV- Powers

This Corporation shall have all the powers conferred upon corporations organized under the laws of the Florida Statutes.

ARTICLE V - Capital Stock

This Corporation is authorized to issue 250 shares of One and no/100 Dollar (\$1.00) par value common stock.

ARTICLE VI - Pre-emptive Rights

Every shareholder, upon the issuance of any new stock of this Corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro-rata share at the price at which it is offered to others.

ARTICLE VII - Initial Registered Agent and Office

ARTICLE VIII - Initial Board of Directors

ARTICLE XI - Indemnification


The Corporation shall indemnify an officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XII - Registered Agent


Pursuant to Chapter 48.091, Florida Statutes, the following is submitted in compliance with this Act:

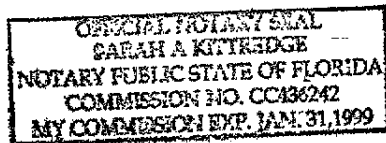


