ARTICLE V - BYLAWS

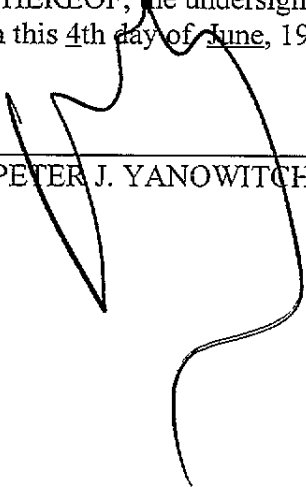
The power to adopt, alter, amend or repeal Bylaws for the Professional Association shall be vested only in the Directors, as more specifically provided in the Bylaws.

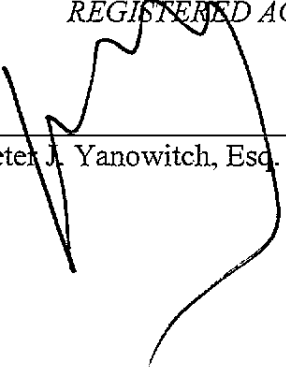
