**ARTICLE I**

**NAME AND PRINCIPAL OFFICE**

**INITIAL REGISTERED OFFICE AND AGENT**



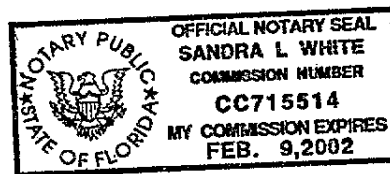


