The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of this corporation is **INTERFACE DENTAL, INC.**

ARTICLE II

This corporation shall have perpetual existence commencing on the date these Articles of Incorporation are filed with the Florida Department of State, Division of Corporations.

ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IX

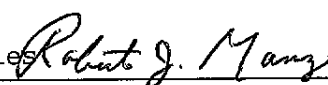
The corporation shall indemnify the officers or directors, or any former officers or directors, to the full extent provided by law.

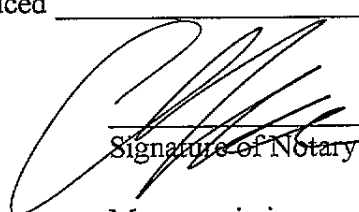

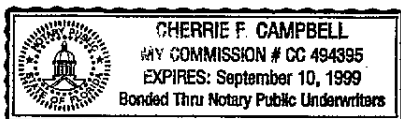
