ARTICLE I - NAME

This Corporation shall have no Directors. The business of the Corporation shall be managed by the Stockholders.

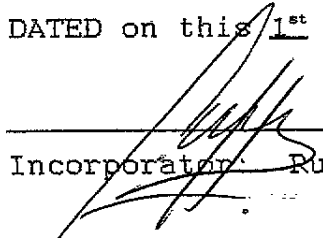

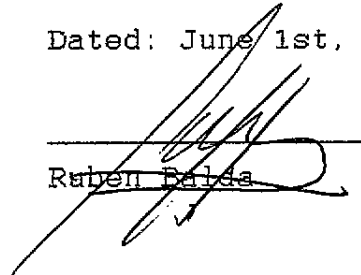
