ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is MARICULTURE DEVELOPMENT CORPORATION

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
